## **AUCTION RULES AND REGULATIONS**

**ALL VEHICLES MUST BE PICKED UP WITHIN (3) BUSINESS DAYS AFTER EACH AUCTION!**

**Our hours are 8am-5pm Monday through Friday**

- 1 NO BIDDER WILL BE RECOGNIZED UNLESS A BIDDER CARD IS BEING USED. YOU ARE RESPONSIBLE FOR THE USE OF YOUR BIDDER CARD.
- 2 **TITLES: ALL VEHICLES PURCHASED MUST BE PAID FOR BEFORE ANY TITLES ARE PROCESSED. ALL VEHICLES MUST BE PAID FOR BY THE MONDAY AFTER EACH AUCTION. CHARGES ARE \$20.00 PER DAY - PER VEHICLE IF NOT PAID FOR BY THE TIME PROVIDED.** TITLES WILL BE READY ON THE 3RD BUSINESS DAY AFTER THE AUCTION, PROVIDED THE MILEAGE HAS BEEN GIVEN, OR UNLESS OTHERWISE NOTED. ANY NON-VIRGINIA RESIDENT WILL TAKE A FEW DAYS LONGER TO PROCESS TITLE. CHECK THE COMMENTS ON YOUR AUCTION LIST FOR DETAILS ABOUT A VEHICLE'S TITLE AVAILABILITY. DO NOT SELL OR SPEND ANY MONEY ON YOUR VEHICLE UNTIL YOU TRANSFER THE TITLE INTO YOUR NAME.
- 3 **VEHICLES MUST BE PICKED UP WITHIN 3 BUSINESS DAYS AFTER EACH AUCTION. NVA AUCTION RESERVES THE RIGHT TO RE-SELL ANY VEHICLE AFTER THE 3-DAY GRACE PERIOD EVEN IF THE VEHICLE(S) HAS BEEN PAID FOR. ALSO YOU WILL AUTOMATICALLY LOSE YOUR DEPOSIT!!!! ALL DEPOSIT RECEIPTS MUST BE TURNED IN WITHIN (3) BUSINESS DAYS AFTER THE AUCTION OR YOU WILL LOSE YOUR DEPOSIT!!!!**
- 4 **NO ONE WILL BE PERMITTED TO REMOVE A VEHICLE UNTIL THE AUCTION IS OVER.**
- 5 **NO VEHICLES ARE TO BE LEFT ON WAKEMAN COURT AT ANY TIME, OR THE SURROUNDING PROPERTIES!!!**
- 6 **ANY VEHICLE LEFT IN OUR LOT AFTER WEDNESDAY WILL BE SUBJECT TO A STORAGE FEE OF \$20.00 PER DAY PER VEHICLE.**
- 7 **ANYONE CAUGHT REMOVING ANY ITEM FROM A VEHICLE WILL BE ASKED TO LEAVE WITHOUT A REFUND OF YOUR DEPOSIT AND YOU WILL BE BANNED FROM ALL FUTURE AUCTIONS.**
- 8 **THE SUCCESSFUL BIDDER WILL PURCHASE THE VEHICLE OR LOSE THE DEPOSIT, BE BANNED FROM ALL FUTURE AUCTIONS AND BE TURNED OVER TO A COLLECTION AGENCY.**
- 9 **VEHICLES WILL BE REMOVED FROM NVA AUCTION PROPERTY BEFORE ANY REPAIRS ARE MADE.**
- 10 **ALL VEHICLES WILL BE SOLD AS IS. "NO REFUNDS" NVA AUCTION IS NOT RESPONSIBLE FOR THE YEAR, MAKE, MODEL, MILEAGE NOR THE KEYS TO THE VEHICLE. NVA AUCTION IS NOT RESPONSIBLE FOR ANY DAMAGE ON VEHICLES LEFT ON LOT AFTER AUCTION DAY.**
- 11 **PAPERWORK WILL ONLY BE PUT IN THE NAME OF THE REGISTERED BUYER, ABSOLUTELY NO EXCEPTIONS. WHEN CALLING ABOUT TITLES, YOU MUST HAVE AUCTION-LETTER AND NUMBER READY (EXAMPLE: G-27). WHEN PICKING UP TITLES, ALSO YOU MUST HAVE THE BILL OF SALE WITH YOU, NO EXCEPTIONS.**
- 12 **ANYONE NEEDING A TITLE THERE WILL BE AN ADDITIONAL \$75.00 PAPERWORK FEE**
- 13 **A BUYERS FEE WILL BE ADDED TO EACH NON- CONSIGNMENT VEHICLE IN THE AMOUNT OF \$50 OR 10% PERCENT WHICHEVER IS HIGHER NOT TO EXCEED \$250.00.**
- 14 **CONSIGNMENT VEHICLES WILL BE CHARGED A \$125 FLAT BUYERS FEE (SEE CONSBUYFEE COLUMN ON YOUR LISTINGS)**
- 15 **REGISTRATION REQUIREMENTS ARE A \$200 CASH DEPOSIT AND A VALID PICTURE ID (DRIVERS LICENSE, PASSPORT, ETC.)**
- 16 **NO WARRANTY: VEHICLES ARE BEING SOLD AS IS, THERE IS NO WARRANTY, EXPRESSED WRITTEN OR IMPLIED. THE SELLER SHALL NOT BE RESPONSIBLE FOR THE CORRECT DESCRIPTION, AUTHENTICITY, GENUINENESS, OR DEFECTS HEREIN, AND MAKES NO WARRANTY IN CONNECTION THEREWITH. NO ALLOWANCE OR SET ASIDE WILL BE MADE ON ACCOUNT OF ANY INCORRECTNESS, IMPERFECTIONS, DEFECT OR DAMAGE.**
- 17 **ANY DISCREPANCIES OR REPRESENTATIONS ARE FOR IDENTIFICATION PURPOSES ONLY AND ARE NOT TO BE CONSIDERED AS A WARRANTY OF ANY TYPE. IT IS THE RESPONSIBILITY OF THE BUYER TO HAVE THOROUGHLY INSPECTED THE VEHICLE AND TO HAVE SATISFIED HIMSELF OR HERSELF AS TO THE CONDITION AND VALUE AND TO BID BASED UPON THAT JUDGMENT SOLELY.**
- 18 **NVA AUTO AUCTION IS NOT RESPONSIBILITY FOR ANY REPAIRS REGARDLESS OF ANY ORAL STATEMENTS ABOUT THE VEHICLE.**
- 19 **BY SIGNING IN YOU ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTAND ALL THE RULES OF THE AUCTION, AND WILL ADHERE TO THEM.**
